The 1st of you as principal borrower and 2nd as guarantor/co-obligant/mortgagor availed:

- a) Commercial Vehicle Loan - I with number 15026900001056 of ₹24,50,000/- (Rupees Twenty-Four Lakh Fifty Thousand only) on 21.08.2023 for purchasing a new vehicle,
