NOTICE FOR SALE OF SECURITY PROPERTIES ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (hereinafter referred to as Act) r/w SECURITY INTEREST (ENFORCEMENT) RULES, 2002 (hereinafter referred to as Rules).

Whereas

Two only) in the FHS loan account, (b) ₹13,62,949/- (Rupees Thirteen Lakh Sixty Two Thousand Nine Hundred and Forty Nine only) in the Property Power loan account and (c) ₹96,772/- (Rupees Ninety Six Thousand Seven Hundred and Seventy Two only) in the Asset Guard loan account as on **08/11/2024** [*Dues as per OA filed on 11/10/2024*] together with further interest, cost and other charges till realization and thus the undersigned being the Authorised Officer of the Bank hereby invites from interested parties, the sealed tenders for purchasing the property subject to the terms and conditions mentioned hereunder.
