The undersigned hereby give notice to the borrowers and general public that the Bank has decided to sell on **14/11/2024** “AS IS WHERE IS” & “AS IS WHAT IS” and “WHATEVER THERE IS BASIS” under Rules 8 & 9 of the said Rules for realizing the dues of **Rs. ₹ 68,71,243.83 (Rupees Sixty-Eight Lakh Seventy-One Thousand Two Hundred Forty-Three and Paise Eighty-Three only)** is due from you as on **14/11/2024** with further interest, cost and other charges thereon and thus the undersigned being the Authorized Officer of the Bank hereby invites from interested the sealed tenders for purchasing the property subject to the terms and conditions mentioned hereunder.

- b) The reserve price below which the security properties in Lot No: 1 will not be sold is ₹ **47,10,000.00** (Rupees Forty-Seven Lakh Ten Thousand only), the security property in Lot no: 2 is ₹ **25,25,000.00** (Rupees Twenty-Five Lakh Twenty-Five Thousand only). **The properties in Lot No.1 and 2 will be sold separately.**

- i) All payments shall be made by way of RTGS/NEFT in the above-mentioned account OR by Demand Draft drawn in favor of The Federal Bank Ltd. payable at Thiruvananthapuram.
- j) The successful bidder shall bear the entire charges / fees payable for conveyance such as stamp duty, Registration fee etc. as applicable as per Law.
