**SALE NOTICE**

**NOTICE FOR SALE OF IMMOVABLE PROPERTY ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (hereinafter referred to as Act) r/w SECURITY INTEREST (ENFORCEMENT) RULES, 2002(hereinafter referred to as Rules).**

Whereas The Federal Bank Ltd (hereinafter referred to as 'the Bank') through its Authorized Officer under the Act issued a demand notice dated 07/03/2023 calling upon the borrowers namely (1) **Mr. Dipan Harshadbhai Chhatbar**, and co-obligants (2) **Mr. Harshadbhai H Chhatbar**, both residing at A/81, Subhlaxmi Tower, Opp Sanghvi School, Ankur Road, Naranpura, Ahmedabad, Gujarat 380013 // 18, New Sharad Society, Near Vijay Nagar School, Naranpura, Ahmedabad, Gujarat 380013, to repay the amount mentioned in the said notice being **Rs. 55,16,286.60 (Rupees Fifty Five Lakh Sixteen Thousand Two Hundred and Eighty Six, paise Sixty only)** together with interest, costs and other charges within 60 days from the date of the said notice.

Whereas the Borrower(s)/guarantor(s) having failed to repay the amount within the stipulated time, the undersigned on behalf of The Federal Bank Ltd. has taken possession of the properties described herein below in exercise of powers conferred under section 13(4) of the said Act read with rule 8 of the said Rules on **25/02/2024** by issuing a notice to the borrowers / guarantors / defaulters and general public and publication thereof in news papers as contemplated under the said Act and Rules.

The undersigned hereby gives notice to the borrower(s) and/or guarantor(s) and/or defaulters and general public that the Bank has decided to sell on **10/10/2024** the properties described herein below on "AS IS WHERE IS, AS IS WHAT IS & WHATEVER THERE IS BASIS" under Rules 8 & 9 of the said Rules for realising an amount of **Rs. 65,43,784.60 (Rupees Sixty Five Lakh Forty Three Thousand Seven Hundred Eighty Four and Paise Sixty Only)** as on **10/10/2024** due from you with further interest and costs/other charges and thus the undersigned hereby invites from interested parties sealed tenders for purchasing the properties subject to the terms and conditions mentioned hereunder.

"While we call upon you to discharge your liability as above by payment of the entire dues to the Bank together with applicable interest, all costs, charges and expenses incurred by the bank till repayment and redeem the secured asset, within the period mentioned above, Please take important note that as per section 13(8) of the SARFAESI Act 2002, (as amended), the right of redemption of secured asset will be available to you only till the date of publication of notice for publication or inviting tenders from public or private treaty for transfer by way of lease, assignment or sale of the secured asset."

Balcony area (As per RERA Act, 2016) together with undivided share of land admeasuring 46.09 sq.mtrs in the scheme known as 'AVADH ELEGANCE' a scheme constructed, situated and lying on land bearing (1) Block No. 240 (Old Survey No.158/7), (2) Block No.242 (Old Survey No.158/5), (3) Block No.242+244 (Old Survey No.158/3 & 158/4), Final Plot No.97.of T. P. 6. The intending purchasers shall remit the EMD through NEFT/RTGS to The Federal Bank Ltd. Account No. 11580051030001, IFSC Code No. FDRL0001158, or DD drawn in favour of The Federal Bank Ltd, payable at Ahmedabad, for Rs. 5,35,000/- (Rupees Five Lakh Thirty Five Thousand Only), before 4:00pm on 09/10/2024, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
7. **The incremental Bid amount will be in the multiple of Rs. 10,000.00 for the property.
