Whereas the Borrower(s)/guarantor(s) having failed to repay the amount within the stipulated time, the undersigned on behalf of The Federal Bank Ltd. has taken possession of the properties described herein below in exercise of powers conferred under section 13(4) of the said Act read with rule 8 of the said Rules on **07/10/2023** by issuing a notice to the borrowers / guarantors / defaulters and general public and publication thereof in news papers as contemplated under the said Act and Rules.

The undersigned hereby gives notice to the borrower(s) and/or guarantor(s) and/or defaulters and general public that the Bank has decided to sell on **05/12/2024** the properties described herein below on "AS IS WHERE IS, AS IS WHAT IS & WHATEVER THERE IS BASIS" under Rules 8 & 9 of the said Rules for realising an amount of **Rs. 4,61,62,391.25 (Rupees Four Crore Sixty One Lakh Sixty Two Thousand Three Hundred Ninety One and Paisa Twenty Five Only) (Balance outstanding as per claim amount in O.A. no. 974/2022 filed before DRT-II, Ahmedabad)** due from you with further interest and costs/other charges and thus the undersigned hereby invites from interested parties sealed tenders for purchasing the properties subject to the terms and conditions mentioned hereunder.

Bounded in East by Garden of AUDA, West by Flat no C-201, North by Flat no. B-203 and south by Flat no. C-203.

6. The intending purchasers shall remit the EMD through NEFT/RTGS to The Federal Bank Ltd. Account No. 14702200000029, IFSC Code No. FDRL0001470, or DD drawn in favour of The Federal Bank Ltd, payable at Ahmedabad, for Rs. 3,23,000/- (Rupees Three Lakh Twenty Three Thousand Only), before 4:00pm on 04/11/2024, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
