The intending purchasers shall submit /send to the undersigned their tender quoting the price offered by them in a sealed cover along with a Demand Draft favoring The Federal Bank Ltd. payable at Chennai for **Rs.3,70,000/- (Rupees Three Lakhs and Seventy Thousand Only)** being earnest money equivalent to 10 % of the Reserve Price for each of the properties mentioned above as item 1 and 2, which is refundable if the tender is not accepted. Bids shall be submitted in the multiples of Rs.10,000/- over and above the reserve price.
