### SALE NOTICE

**NOTICE FOR SALE OF IMMOVABLE PROPERTY ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (hereinafter referred to as Act) r/w SECURITY INTEREST (ENFORCEMENT) RULES, 2002(hereinafter referred to as Rules).**

Whereas The Federal Bank Ltd (hereinafter referred to as 'the Bank') through its Authorized Officer under the Act issued a demand notice dated **13/04/2023** calling upon the borrowers namely **(1) Mrs. Sharmila Shivkumar Goud, W/o Shivkumar Narottam Gaud, and (2) Mr. Shivkumar Narottam Gaud, S/o Narottam Brijmohan Gaud, both residing at 54 Subhash Nagar Society Puna Kumbhariya, Road near Amezia Park Kumbharia, Surat, Gujarat, Pin-395010 // 90, Aaradhna Green Valley Vibhag 1, Tantithaiya, Palsana, Surat, Gujarat, Pin-394345,** to repay the amount mentioned in the said notice being **Rs.9,93,247.72(Rupees Nine Lakh Ninety Three Thousand Two Hundred and Forty Seven, paise Seventy Two only) under your FHS loan with number 21957300001563** together with interest, costs and other charges within 60 days from the date of the said notice.

Whereas the Borrower(s)/guarantor(s) having failed to repay the amount within the stipulated time, the undersigned on behalf of The Federal Bank Ltd. has taken possession of the properties described herein below in exercise of powers conferred under section 13(4) of the said Act read with rule 8 of the said Rules on **12/05/2024** by issuing a notice to the borrowers / guarantors / defaulters and general public and publication thereof in news papers as contemplated under the said Act and Rules.

6. The intending purchasers shall remit the EMD through NEFT/RTGS to The Federal Bank Ltd. Account No. 21952200000013, IFSC Code No. FDRL0002195, or DD drawn in favour of The Federal Bank Ltd, payable at Surat, for Rs. 97,500/- (Rupees Ninety Seven Thousand Five Hundred Only), before 4:00pm on 17/10/2024, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
