Pothencode within 60 days from the date of receipt of the said notice.

Whereas the borrower(s) and / or guarantor (s) and / or defaulters having failed to repay the amount within the stipulated time, the authorized officer on behalf of the Federal Bank Ltd. has taken possession of the property described herein below in exercise of powers conferred under section 13(4) of the said Act read with Rule 8 of the said Rules on 02.01.2021 by issuing a notice to the borrowers/defaulters and general public and publication thereof in newspapers as contemplated under the said Act and Rules. Thereafter actual possession was taken/affected on 03.01.2021 in compliance of the order of Hon'ble Chief Judicial Magistrate Court, Thiruvananthapuram in MC 78/2021. Later again as per the order the Hon'ble CJM Court, Thiruvananthapuram the bank has taken full possession of the property on 24.04.2023.

 - b) The reserve price below which the security properties in Lot No: 1 will not be sold is ₹ 94,55,000.00 (Rupees Ninenty Four Lakhs Fifty Five Thousand only)
 - c) The EMD shall be remitted through NEFT/RTGS to The Federal Bank Ltd, to the Account No. 21462200000013, IFSC CODE: FDRL0002146, or by way of Demand Draft (DD) favoring 'Authorised Officer, The Federal Bank Ltd.' payable at Thiruvananthapuram.
- d) The intending purchasers shall submit/send to the undersigned their tender quoting the price offered by them in a sealed cover along with the details of EMD remitted by way of RTGS/NEFT/ Demand Draft favoring The Federal Bank Ltd payable at Thiruvananthapuram for property in Lot no.1 is ₹ 9,45,500/- being earnest money equivalent to 10 % of the Reserve Price of the properties concerned, which is refundable if the tender is not accepted.
