Late Mr. Johnson Mari Immanuel (principal borrower) availed Federal Personal Car loan (FPCL) with number 15007400004600 of ₹16,80,000/- (Rupees Sixteen Lakh Eighty Thousand only) on 12/12/2022 from The Federal Bank Limited a company registered under the Companies Act 2013 having registered office at Aluva (hereinafter referred to as the bank) through its branch at **Pune/Kothrud** for purchase of a brand-new car.

- 1. In consideration thereof, Late Mr. Johnson Mari Immanuel executed in favour of the Bank security agreements/documents etc. on the relevant date, whereby Late Mr. Johnson Mari Immanuel admitted and agreed to the terms and conditions of the said credit facility. To secure the due repayment of the said Facility, Late Mr. Johnson Mari Immanuel had created security interest in favour of the Bank by way of hypothecation in respect of equipment/asset/vehicle as specifically mentioned in the said Loan Agreement (herein afterwards as "said equipment/asset/vehicle").

As Late Mr. Johnson Mari Immanuel have committed default in payment of the EMI's on due dates in violation of the terms and conditions of the Loan Agreement.
- 4. Considering the default on part of deceased borrower Late Mr. Johnson Mari Immanuel, you as Legal heir have voluntarily surrendered the vehicle to the bank on 14/10/2024. The undersigned being Authorised Officer of the Federal Bank Limited hereby informs you that a sum of ₹16,21,566/- (Rupees Sixteen Lakh Twenty One Thousand Five Hundred & Sixty Six Only) is due from you as on 02/10/2024 along with repossession charges and all other fees/expenses as on the above date within 10 days from the date of this notice and take repossession of the said equipment/vehicle/ asset failing which Bank will be constrained to
