NOTICE FOR SALE OF IMMOVABLE PROPERTY ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (Hereinafter referred to as Act) R/w SECURITY INTEREST (ENFORCEMENT) RULES, 2002 (hereinafter referred to as Rules).

Whereas the Authorized Officer of the Federal Bank Limited, under the Act, issued a demand notice dated 20/06/2023, calling upon the borrowers and defaulters, 1) Mr. Umesh Shivaji Dhuri, Son of Mr. Shivaji Deu Dhuri, and 2) Mrs. Uma Umesh Dhuri, Wife of Mr. Umesh Shivaji Dhuri, both residing at Chatrapati Shivaji Sanghna ,V P path, Manjunath Vidyala, Indira Nagar, Dombivli (East), Kalyan, Thane, Mumbai, Maharashtra – 421201 and also at Flat No.103, 1st Floor, C Wing, IRA ICON Building, Behind Sarvodaya Orchid, Nandivali Road, Taluka Kalyan, Dombivli East, Thane, Maharashtra – 400612, to repay the amount mentioned in the notice being Rs. 30,16,743/- (Rupees Thirty Lakhs Sixteen Thousand Seven Hundred Forty Three Only) together with interest and costs within 60 days from the date of receipt of the said notice

Whereas the borrower's having failed to repay the amount within the stipulated time, the Authorized Officer on behalf of the Federal Bank Limited has taken physical possession of the property described herein below in exercise of powers conferred under section 13(4) of the said Act read with rule 8 of the said Rules on 27th day of December 2024 by issuing a notice to the borrowers and general public and publication thereof in newspapers as contemplated under the said Act and Rules.

The undersigned hereby give notice to the borrowers/defaulters and general public that the Bank has decided to sell on 18/03/2025, the property described herein below on "AS IS WHERE IS" "AS IS WHAT IS" & "WHATEVER THERE IS BASIS" under Rules 8 & 9 of the said Rules for realizing the dues of Rs.36,72,191/- (Rupees Thirty Six Lakhs Seventy Two Thousand One Hundred and Ninety One Only) as on 18/03/2025, together with further interest and cost/other charges thereon due from the borrowers under loan account: 13587300007953, with Branch: Dombivli of The Federal Bank Limited and thus the undersigned hereby invites tenders from interested parties for purchasing the property subject to the terms and conditions mentioned hereunder.

Description of Property

All the piece and parcel of the Residential Flat admeasuring about 504 sq.ft. Carpet area (Built up area 720 Sq.ft) being Flat No.103 on the First Floor in the Wing ‘C’ of the Building known as ‘IRA ICON’ constructed on the portion of all the piece and parcel of land admeasuring about 2700 sq.mtrs. bearing Survey No.73, Hissa No 4, situate, lying and being at Village Nandivli, Taluka Kalyan, District and Registration district of Thane and Sub-Registration district of Kalyan and within the limits of Kalyan Dombivli Municipal Corporation bounded as per title deed on East : Survey No 42, West : Survey No 15 and Survey No 3, North : Survey No 5, South : Survey No 1 and bounded presently on East : Flat No 102, West : “B”Wing, North : Under construction Project, South : “D”Wing.

1. The Reserve price below which the property will not be sold is Rs.30,50,000/- (Rupees Thirty Lakhs and Fifty Thousand Only).

6. The EMD shall be remitted through EFT/NEFT/RTGS to the Federal Bank Account No 14030051030001, IFSC Code No. FDRL0001403 as mentioned above for Rs.3,05,000/- (Rupees Three Lakhs and Five Thousand Only), before 3.00 PM on 17/03/2025, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
7. The incremental Bid amount will be in the multiple of Rs. 5,000.00 (Rupees Five Thousand Only). The successful bidders shall deposit 25% of the bid amount / sale price (less EMD) immediately on acceptance of his tender/ offer by the Bank and the balance 75% within 15 days, failing which the entire deposit made by him shall be forfeited without any notice and the properties concerned will be re-sold.
