**SALE NOTICE**

**NOTICE FOR SALE OF IMMOVABLE PROPERTY ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (Hereinafter referred to as Act) R/w SECURITY INTEREST (ENFORCEMENT) RULES, 2002 (hereinafter referred to as Rules).**

Whereas the Authorized Officer of the Federal Bank Limited, under the Act issued a **demand notice dated 29/05/2019** calling upon the borrowers and defaulters **(1) Mr. Suresh Khajappa Patole and (2) Mrs. Vijayalaxmi Suresh Patole, both residing at Flat No. 602, B Wing, Shakuntala Paradise, Shivaji Chowk, Village Nilje, Lodha Heaven, Dombivli (East) – 421201, and also at Z-1, Flat No. 220, Balaji Nisarg, Gate No. 48, Ahmednagar Road, Shirsawadi, Vadebolhai, Wagholi, City Pune – 412207, to repay the amount mentioned in the said notice being Rs. 30,30,156.00 (Rupees Thirty Lakhs Thirty Thousand One Hundred and Fifty Six Only) together with further interest thereon with monthly rests till payment being the amount due under various credit facility availed by them from our Branch: Panvel within 60 days from the date of the said notice.**

Whereas the borrower's having failed to repay the amount within the stipulated time, the Authorized Officer on behalf of the Federal Bank Limited has taken physical possession of the property described herein below in exercise of powers conferred under section 13(4) of the said Act read with rule 8 of the said Rules on **23<sup>rd</sup> day of September 2022** by issuing a notice to the borrowers and general public and publication thereof in newspapers as contemplated under the said Act and Rules.

The undersigned hereby give notice to the borrowers/defaulters and general public that the Bank has decided to sell on **04/04/2025**, the properties described herein below on **“AS IS WHERE IS” “AS IS WHAT IS” & “WHATEVER THERE IS BASIS” under Rules 8 & 9** of the said Rules for realizing the dues of **Rs.39,31,757.93 (Rupees Thirty Nine Lakhs Thirty One Thousand Seven Hundred Fifty Seven and Ninety Three Paise Only) as on 16/07/2022 (claim amount as per Original Application filed before Hon’ble Debts Recovery Tribunal – Pune, Diary No.1368 of 2022)** along with further interest, charges and cost thereon from 17/07/2022 is due from you under the loan account: 14757300002978 till realization and thus the undersigned hereby invites tenders from interested parties for purchasing the property subject to the terms and conditions mentioned hereunder.

***All that piece and parcel of residential flat No. 602, admeasuring 890 sq ft built up area, on the 6<sup>th</sup> floor of B Wing, in the building known as Shakuntala Paradise, Lodha Heaven, and constructed on the Survey No. 39/1B of village Nilje, Dombivli (East), Taluka Kalyan, District Thane, State Maharashtra, and bounded on the East by Railway Track, on the South by New Under Construction building, on the West by Lodha Club House, and on the North by Open Plot.***

1. The Reserve price below which the property will not be sold is Rs.28,84,000/- (Rupees Twenty Eight Lakhs and Eighty Four Thousand Only).
2. The property will be sold by e-auction through the Bank’s approved service provider M/S E-Procurement Technologies Ltd. – Auction Tiger on 04/04/2025 between 11.30 AM to 1.30 PM under the supervision of the Authorised officer of the Federal Bank Limited.

The EMD shall be remitted through EFT/NEFT/RTGS to the Federal Bank Account No 14030051030001, IFSC Code No. FDRL0001403 as mentioned above for Rs.2,88,400/- (Rupees Two Lakhs Eighty Eight Thousand and Four Hundred Only), before 3.00 PM on 03/04/2025, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
7. The incremental Bid amount will be in the multiple of Rs. 5,000.00 (Rupees Five Thousand Only). The successful bidders shall deposit 25% of the bid amount / sale price (less EMD) immediately on acceptance of his tender/ offer by the Bank and the balance 75% within 15 days, failing which the entire deposit made by him shall be forfeited without any notice and the properties concerned will be re-sold.
