The undersigned hereby give notice to the borrowers/defaulters and general public that the Bank has decided to sell on 23/04/2025, the property described herein below on "AS IS WHERE IS" "AS IS WHAT IS" & "WHATEVER THERE IS" basis under Rules 8 & 9 of the said Rules for realizing the dues of Rs.47,00,724.51 (Rupees Forty Seven Lakhs Seven Hundred Twenty Four and Paise Fifty one Only) as on 23/04/2025 along with further interest, charges and cost thereon from 24/04/2025 due from the borrowers under Federal ODCC Limit: 12855600002904 with Branch: Mumbai / Crawford Market of The Federal Bank Limited and thus the undersigned hereby invites tenders/e-bids from interested parties for purchasing the property subject to the terms and conditions mentioned hereunder.

1. The Reserve price below which the property will not be sold is Rs.92,00,000/- (Rupees Ninety-Two Lakhs Only).

6. The EMD shall be remitted through EFT/NEFT/RTGS to the Federal Bank account no. A/c No 14030051030001, IFSC Code No. FDRL0001403 as mentioned above for Rs.9,20,000/- (Rupees Nine Lakhs Twenty Thousand Only), before 3.00 PM on 22/04/2025, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
