NOTICE FOR SALE OF IMMOVABLE PROPERTY ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (hereinafter referred to as Act) r/w SECURITY INTEREST (ENFORCEMENT) RULES, 2002(hereinafter referred to as Rules).

Whereas The Federal Bank Ltd (hereinafter referred to as 'the Bank') through its Authorized Officer under the Act issued a demand notice dated 26/05/2023 calling upon the borrowers namely (1) **Chhaganbhai V Padhara, S/o Vallabhbhai Manjibhai Padhara**, and co-obligants (2) **Mr. Mukundbhai Chhaganbhai Padhara, S/o Chhaganbhai Valabhbhai Padhara**, both residing at **125, Shamla Row House, Laskana, Surat, Gujarat, 395008**, to repay the amount mentioned in the said notice being **Rs. 30,00,218/- (Rupees Thirty Lakh Two Hundred and Eighteen only) due from you as on 06.05.2023 under your FHS loan with number 17987300001905 and Rs. 23,62,056.38 (Rupees Twenty Three Lakh Sixty Two Thousand and Fifty Six, paise Thirty Eight only) due from you as on 05.05.2023 under your Federal Home Plus Top Up Equity loan with number 17987600001456** together with interest, costs and other charges within 60 days from the date of the said notice.

Whereas the Borrower(s)/guarantor(s) having failed to repay the amount within the stipulated time, the undersigned on behalf of The Federal Bank Ltd. has taken possession of the properties described herein below in exercise of powers conferred under section 13(4) of the said Act read with rule 8 of the said Rules on **30/06/2024** by issuing a notice to the borrowers / guarantors / defaulters and general public and publication thereof in news papers as contemplated under the said Act and Rules.

The undersigned hereby gives notice to the borrower(s) and/or guarantor(s) and/or defaulters and general public that the Bank has decided to sell on **04/02/2025** the properties described herein below on "AS IS WHERE IS, AS IS WHAT IS & WHATEVER THERE IS BASIS" under Rules 8 & 9 of the said Rules for realising an amount of **Rs. 34,71,070/- (Rupees Thirty Four Lakh Seventy One Thousand Seventy only) due as on 04/02/2025 under your FHS loan with number 17987300001905 and Rs. 28,39,999.38 (Rupees Twenty Eight Lakh Thirty Nine Thousand Nine Hundred Ninety Nine, paise Thirty Eight only) due on 04/02/2025 under your Federal Home Plus Top Up Equity loan with number 17987600001456** due from you with further interest and costs/other charges and thus the undersigned hereby invites from interested parties sealed tenders for purchasing the properties subject to the terms and conditions mentioned hereunder.

6. The intending purchasers shall remit the EMD through NEFT/RTGS to The Federal Bank Ltd. Account No. 17982200000057, IFSC Code No. FDRL0001798, or DD drawn in favour of The Federal Bank Ltd, payable at Surat, for Rs. 4,05,000/- (Rupees Four Lakh Five Thousand Only), before 4:00pm on 03/02/2025, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
7. **The incremental Bid amount will be in the multiple of Rs. 10,000.00 for the property. The successful bidders shall deposit 25% of the bid amount / sale price (less EMD) immediately on acceptance of his tender/ offer by the Bank and the balance 75% within 15 days, failing which the entire deposit made by him shall be forfeited without any notice and the properties concerned will be re-sold.**
